WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

AND, WHEREAS, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned

The applicant Institution for additional unit will be required to submit the required documents, such as, land documents, Non-Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided the additional flicilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting Team at the time of inspection. The Regional Committee shall arrange for verification of documents, inspection of the premises and check addiscence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the institution shall not be permitted to admit students for the

has failed to comply with these requirements, the institution shall not be permitted to admit students for the scademic year 2016-2017.

In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act Complaint etc. the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the offiliating body/State Govt, and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Senior 17 complaint enser etc. as decided by the Northern Regional Committee

#### ORDER

- The institutions shall ensure the fulfillment of the following:-

- The institutions shall maintain the teaching staff strength as per NCTE norms applicable to respective course/s approved. The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time. The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank
- only to be operated along with an authorized official of the Regional Committee.

  That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the managements / institutions.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government / SCERT etc.



The institutions shall submit to the Regional Committee a The institutions shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

The institutions shall regularly update their website.

The institutions intending to run the teacher training programme approved above in a rented premises are required to shift to their permanent building. They are required to submit report in compliance of the requirement

of NCTE Regulations on the subject.

Attention of the institutions concerned is also drawn to Section 12 of NCTE Regulation dt. 27.12.2005 which reads as "The institution concerned, after appointing the requisite faculty / staff, shall put the information on its official website and also formally inform the Regional Committee concerned. The Regional committee concerned shall then issue a formal unconditional recognition order."

5. If any of the institution contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17 (1) of the NCTE Act, 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993. 1993.
